<u>Friday, February 24, 2023:</u> – The New York State Cannabis Control Board has announced that the following meeting has been scheduled:

<u>Thursday, March 2, 2023</u> – The New York State Cannabis Control Board will hold a public meeting of the Board at 10:00 a.m. on <u>Thursday March 2<sup>nd</sup></u>, at 515 Broadway Albany, NY 12207 and via real-time live streaming. Board Member Adam W. Perry will be joining via live stream from 181 Ellicott St. Buffalo, NY 14203, which is also open to the public for in-person viewing. Board Members Jennifer Gilbert Jenkins and Jessica García will be joining via live stream from a private location due to extraordinary circumstances.

- Open to the Public: This meeting will be open to the public. Due to space limitations at the meeting venue only a limited number of members of the public will be able to attend this meeting in person. Members of the public are encouraged, but not required to, pre-register if they wish to attend in person to facilitate easier check-in prior to the meeting. Registration is not required to view the livestreaming video link.
- <u>Public Comment:</u> Public comment will be allowed during a designated comment period as part of this meeting. Participating individuals should indicate their desire to participate in public comment when preregistering and/or checking in prior to the meeting. Individuals must limit their remarks to two minutes and remarks should be related to specific agenda items. Additional comments may be submitted online using the public comment form below. Online submissions will be part of the official record of the meeting and be documented in the meeting minutes. All online comments must be submitted by 5 p.m. on Thursday, March 2<sup>nd</sup>.
