RESOLUTION APPROVING A CERTAIN APPLICATION FORM FOR A CONDITIONAL ADULT-USE RETAIL DISPENSARY LICENSE AND DIRECTING THAT A NEW APPLICATION PERIOD FOR CONDITIONAL ADULT-USE RETAIL DISPENSARY LICENSES OPEN AND CLOSE ON DATES TO BE ESTABLISHED BY THE OFFICE

WHEREAS, pursuant to Article 4 of the Cannabis Law, the Cannabis Control Board (Board) is charged with the responsibility of overseeing activities related to adult-use cannabis;

WHEREAS, the Office of Cannabis Management (Office) has developed the attached application form for a conditional adult-use retail dispensary license;

WHEREAS, the Office and the Board desire to make the application form available to applicants who are eligible to apply pursuant to the criteria set forth in Section 64 of the Cannabis Law;

WHEREAS, pursuant to Section 10(19) of the Cannabis Law, the Board has the function, power and duty to approve the opening of new license application periods;

WHEREAS, the Board desires to open a new license application period for conditional adult-use retail dispensary licenses;

WHEREAS, no less than fourteen days (14) days prior to the commencement of the new license application period for the conditional adult-use retail dispensary license, the Board desires that the Office post on the Office website the opening date for the new conditional adult-use retail dispensary license application period, as well as the closing date for the new conditional adult-use retail dispensary license application period, which shall be no less than thirty (30) days from the opening date ; now, therefore, be it

RESOLVED, the Board hereby establishes a new license application period for conditional adult-use retail dispensary licenses;

RESOLVED, the Board hereby approves the attached application form for conditional adult-use retail dispensary licenses; and

RESOLVED, the Board hereby directs the Office, no less than fourteen days (14) days prior to the commencement of the new license application period for the conditional adult-use retail dispensary license, to post on the Office website the opening date for the new conditional adult-use retail dispensary license application
