## RESOLUTION ISSUING CERTAIN CONDITIONAL ADULT-USE RETAIL DISPENSARY LICENSES

**WHEREAS**, pursuant to Article 4 and Section 10(1) of the Cannabis Law, the Cannabis Control Board (Board) is given the discretion to issue licenses related to adult-use cannabis;

**WHEREAS**, pursuant to Article 4 of the Cannabis Law, the Board is charged with the responsibility of overseeing activities related to adult-use cannabis;

**WHEREAS**, pursuant to Sections 62, 64, 72 and 85 of the Cannabis Law, the Board is charged with the responsibility of overseeing applications for adult-use cannabis retail dispensary licenses, selection criteria for adult-use cannabis retail dispensary licenses, and ownership and operation of adult-use cannabis retail dispensary licenses;

**WHEREAS**, the Chairperson of the Board has made a preliminary determination to grant provisional conditional adult-use retail dispensary licenses to certain individuals and entities that have applied for a conditional adult-use retail dispensary licenses;

**WHEREAS**, the members of the Board waive their right pursuant to Section 10(1) of the Cannabis Law to take up to 14 days from the Chairperson’s preliminary determination to object to the Chairperson’s preliminary determination or to request that the matter be brought before the full Board for consideration;

**WHEREAS**, no member of the Board objects to the Chairperson’s preliminary determination to grant certain provisional conditional adult-use retail dispensary licenses, and no member of the Board requests that the matter be brought before the full Board for consideration;

**WHEREAS**, the Board desires to issue a license to every applicant that has received the Chairperson’s aforementioned preliminary determination [Attachment A] to grant a provisional conditional adult-use retail dispensary license; now, therefore, be it

**RESOLVED**, the Board issues a provisional conditional adult-use retail dispensary licenses to every applicant that has received the Chairperson’s aforementioned preliminary determination to grant a provisional conditional adult-use retail dispensary license;

**BE IT FURTHER RESOLVED**, the Board dictates that a provisional conditional adult-use retail dispensary licensee shall not begin operations until the completion of a secondary supplemental application to the satisfaction of the Office, including completing a notification to the appropriate municipality where the conditional adult-use
