## RESOLUTION APPROVING CERTAIN APPLICATION FORMS FOR ADULT-USE CANNABIS LICENSES AND DIRECTING THAT A NEW APPLICATION PERIOD FOR CERTAIN ADULT-USE LICENSE TYPES OPEN AND CLOSE ON DATES SET HEREIN

**WHEREAS**, pursuant to Section 13 of the Cannabis Law, the Cannabis Control Board (Board) has the authority to perform such acts, prescribe such forms, and propose such rules, regulations, and orders as it deems necessary or proper to fully effectuate the provisions of the Cannabis Law;

**WHEREAS**, pursuant to Section 10(9) of the Cannabis Law, the Board is charged with prescribing forms of applications for registrations, licenses and permits under the Cannabis Law;

**WHEREAS**, the Office of Cannabis Management (Office) has developed the attached adult-use application forms for certain types of adult-use cannabis licenses (Certain AU License Types);

**WHEREAS**, the Office and the Board desire to make the application forms available to applicants who are eligible to apply pursuant to the criteria set forth in Article 4 of the Cannabis Law;

**WHEREAS**, pursuant to Section 10(19) of the Cannabis Law, the Board has the function, power and duty to approve the opening of new license application periods;

**WHEREAS**, the Board desires to open a new license application period for the application of Certain AU License Types, and the announcement of the application window shall be set herein and be posted on the Office’s website; now, therefore, be it

**RESOLVED**, the Board hereby establishes a new application period for Certain AU License Types which shall open on October 4<sup>th</sup>, 2023 8:00 AM Eastern Time and close on December 4, 2023 at 5:00 PM Eastern Time. Provided however, the Office will commence its first review and approval process for applicants who apply with control over a proposed retail dispensary or microbusiness location by 5:00 PM Eastern Time on Friday, November 3, 2023. The retail dispensary and microbusiness licenses applications will remain open to collect applications for provisional licensure until the 5:00 PM Eastern Time on Monday, December 4, 2023, application deadline.

**RESOLVED**, the Board hereby approves the attached application forms for Certain AU License Types.
