RESOLUTION APPROVING CERTAIN APPLICATION FORMS FOR REGISTERED ORGANIZATIONS AND DIRECTING THAT A NEW APPLICATION PERIOD FOR REGISTERING REGISTERED ORGANIZATIONS OPEN AND CLOSE ON DATES TO BE ESTABLISHED BY THE OFFICE OF CANNABIS MANAGEMENT

WHEREAS, pursuant to Section 13 of the Cannabis Law, the Cannabis Control Board (Board) has the authority to perform such acts, prescribe such forms, and propose such rules, regulations, and orders as it deems necessary or proper to fully effectuate the provisions of the Cannabis Law;

WHEREAS, pursuant to Section 10(9) of the Cannabis Law, the Board is charged with prescribing forms of applications for registrations, licenses and permits under the Cannabis Law;

WHEREAS, pursuant to Section 35 of the Cannabis Law, an applicant for registration as a registered organization under Section 34 of Article 3 of the Cannabis Law must provide certain information to the Board prior to registration approval;

WHEREAS, pursuant to Section 113 of Title 9 of the New York Codes, Rules and Regulations (9 NYCRR), an entity must submit an application for registration as a registered organization with the Office of Cannabis Management (Office) for subsequent approval or denial by the Board;

WHEREAS, the Office has developed the attached application form for registration of registered organizations;

WHEREAS, pursuant to Section 10(19) of the Cannabis Law, the Board has the function, power and duty to approve the opening of new license application periods;

WHEREAS, the Board desires to open a new license application period for registration of registered organizations;

WHEREAS, the Office and Board desire to open a new application period for registered organization registrations, and the announcement of the application window shall be set by the Office and posted on the Office’s website; now, therefore, be it

RESOLVED, the Board hereby establishes a new application period for registration of registered organizations to be set by the Office;
