## RESOLUTION APPROVING CERTAIN APPLICATION FORMS FOR CANNABIS RESEARCH LICENSES AND DIRECTING THAT A NEW APPLICATION PERIOD FOR CANNABIS RESEARCH LICENSES OPEN AND CLOSE ON DATES TO BE ESTABLISHED BY THE OFFICE OF CANNABIS MANAGEMENT

**WHEREAS**, pursuant to Section 13 of the Cannabis Law, the Cannabis Control Board (Board) has the authority to perform such acts, prescribe such forms, and propose such rules, regulations, and orders as it deems necessary or proper to fully effectuate the provisions of the Cannabis Law;

**WHEREAS**, pursuant to Section 10(9) of the Cannabis Law, the Board is charged with prescribing forms of applications for registrations, licenses and permits under the Cannabis Law;

**WHEREAS**, pursuant to Section 38 of the Cannabis Law, the Board is charged with establishing a cannabis research license that permits a licensee to produce, process, purchase, and/or possess certain cannabis or cannabis products for limited research purposes;

**WHEREAS**, pursuant to Subdivision 5 of Section 38 of the Cannabis Law, the Board has the authority to adopt regulations governing the application for a cannabis research license, including establishing application requirements and any additional requirements the Board deems necessary;

**WHEREAS**, the Office of Cannabis Management (Office) has developed the attached application forms for cannabis research licenses;

**WHEREAS**, the Office and the Board desire to make the application forms available to applicants who are eligible to apply pursuant to the criteria set forth above;

**WHEREAS**, pursuant to Section 10(19) of the Cannabis Law, the Board has the function, power and duty to approve the opening of new license application periods;

**WHEREAS**, the Board desires to open a new license application period for the application of cannabis research licenses;

**WHEREAS**, the Office and Board desire to open a new application period for cannabis research licenses, and the announcement of the application window shall be set by the Office and posted on the Office's website; now, therefore, be it
