Tuesday, October 17, 2023 – The New York State Cannabis Control Board will hold a public meeting of the Board at 10:00 A.M. on **Tuesday, October 17, 2023, at SUNY Global Center, 116 E 55th St., Global Classroom, New York, NY 10022.** Board Member Jennifer Gilbert Jenkins will be joining via live stream from SUNY Morrisville, Bicknell Hall, Room 212, 80 Eaton St. Morrisville, NY 13408 in a location accessible to the public. Board Member Adam Perry will be joining from 181 Ellicott St., Buffalo, NY 14203 in a location accessible to the public. Board Member Hope Knight will be joining via live stream from a private location due to extraordinary circumstances.

- **Open to the Public:** This meeting will be open to the public. Due to space limitations at the meeting venue, only a limited number of members of the public will be able to attend this meeting in person. Online submissions will be part of the official record of the meeting and be documented in the meeting minutes. All online comments must be submitted by 5 p.m. on Friday, October 20.
