



## What Income Do I Show to Receive Extra Priority?

The Marijuana Regulation and Taxation Act (MRTA) specifies that certain Social and Economic Equity (SEE) applications receive extra priority. Extra priority shall be given to SEE applicants that demonstrate that an applicant (i) is a member of a community disproportionately impacted by the enforcement of cannabis prohibition; (ii) has an income lower than eighty percent of the median income of the county in which the applicant resides; and (iii) was convicted of a cannabis-related offense prior to the effective date of the MRTA (March 31, 2021), or had a parent, guardian, child, spouse, or dependent, or was a dependent of an individual who, prior to March 31, 2021, was convicted of a cannabis-related offense.

If you are a SEE applicant residing in New York State and wish to receive extra priority, you must submit federal, state, or local documentation proving that your income is less than the threshold for your county below<sup>1</sup>:
