## RESOLUTION TO ISSUE CERTAIN CANNABIS RESEARCH LICENSES

**WHEREAS**, pursuant to Section 10(1) of the Cannabis Law, the Cannabis Control Board (Board) has the authority to issue any registration, license or permit;

**WHEREAS**, pursuant to Article 3 Section 38 of the Cannabis Law, the Board shall establish a cannabis research license that permits a licensee to produce, process, purchase and/or possess cannabis for certain research purposes;

**WHEREAS**, pursuant to Section 132.3 of Title 9 of the New York Codes, Rules and Regulations, in order to be granted a Cannabis Research License, an applicant must meet certain criteria and submit certain information through the submission of an application with the Office of Cannabis Management (Office) for subsequent approval or denial by the Board;

**WHEREAS**, certain research applicants have completed such application to the satisfaction of the Office;

**WHEREAS**, pursuant to Section 10(1) of the Cannabis Law, the Chairperson of the Board has made a preliminary determination to issue a cannabis research license to certain applicants that have applied for the license;

**WHEREAS**, the members of the Board waive their right pursuant to Section 10(1) of the Cannabis Law to take up to 14 days from the Chairperson’s preliminary determination to object to the Chairperson’s preliminary determination or to request that the matter be brought before the full Board for consideration;

**WHEREAS**, no member of the Board objects to the Chairperson’s preliminary determination to issue a Cannabis Research License to certain applicants that have applied for the license;

**WHEREAS**, the Board desires to issue a Cannabis Research License to every applicant that have received the Chairperson’s aforementioned preliminary determination [Attachment A] to grant a Cannabis Research license; now, therefore, be it

**RESOLVED**, that the Board issues Cannabis Research Licenses to the applicants included in Attachment A.
