



## Adult-Use Application and Licensing Fee Schedules

**Application Fees.** An application for a license (except a ROD or ROND license) must be accompanied by a non-refundable application fee of \$1,000. Applications for an ROD and ROND license must be accompanied by a non-refundable application fee of \$10,000.

A qualified social and economic equity (SEE) applicant shall receive a 50% reduction in all application fees and license fees.

**\*\*Please note that the application fee and licensing fee are two separate payments.\*\*** Application fees are collected at the time of submitting an application for a license. Licensing fees are collected after the approval of the application for licensure by the Cannabis Control Board. Licensing fees are detailed below by license type and amount.

**Licensing Fees.** Prior to final issuance of a license, an applicant shall pay a licensing fee for the specific license type as follows.

Adult-Use (AU) Nursery License	
Maximum outdoor area of 100,000 sq. ft.	\$750
Maximum mixed light area of 10,000 sq. ft.	\$1,000
Maximum area of 10,000 sq. ft.	\$2,000

AU Cultivator License: Outdoor	
Outdoor Tier 1	\$1,000+\$150 per 500 sq. ft. of cultivation canopy
Outdoor Tier 2	\$2,500+\$250 per 500 sq. ft. of cultivation canopy over 5,000 sq. ft.
Outdoor Tier 3	\$6,250+\$350 per 500 sq. ft. of cultivation canopy over 12,500 sq. ft.
Outdoor Tier 4	\$15,000+\$500 per 500 sq. ft. of cultivation canopy over 25,000 sq. ft.
Outdoor Tier 5	\$40,000+\$800 per 500 sq. ft. of cultivation canopy over 50,000 sq. ft.

AU Cultivator License: Mixed Light	
Mixed Light Tier 1	\$1,500+\$290 per 500 sq. ft. of cultivation canopy
Mixed Light Tier 2	\$4,380+\$440 per 500 sq. ft. of cultivation canopy over 5,000 sq. ft.
Mixed Light Tier 3	\$10,940+\$615 per 500 sq. ft. of cultivation canopy over 12,500 sq. ft.
Mixed Light Tier 4	\$26,250+\$875 per 500 sq. ft. of cultivation canopy over 25,000 sq. ft.

AU Cultivator License: Indoor	
Indoor Tier 1	\$1,750+\$450 per 500 sq. ft. of cultivation canopy
Indoor Tier 2	\$6,250+\$625 per 500 sq. ft. of cultivation canopy over 5,000 sq. ft.
Indoor Tier 3	\$15,630+\$880 per 500 sq. ft. of cultivation canopy over 12,500 sq. ft.
Indoor Tier 4	\$37,500+\$1,250 per 500 sq. ft. of cultivation canopy over 25,500 sq. ft.
Indoor Tier 5	\$100,000+\$2,000 per 500 sq. ft. of cultivation canopy over 50,000 sq. ft.

AU Cultivator License: Combination	
Combination Tier 1	\$1,250+\$150 per 500 sq. ft. of cultivation canopy
Combination Tier 2	\$3,500+\$235 per 500 sq. ft. of cultivation canopy over 7,500 sq. ft.
Combination Tier 3	\$8,750+\$375 per 500 sq. ft. of cultivation canopy over 18,750 sq. ft.
Combination Tier 4	\$21,000+\$585 per 500 sq. ft. of cultivation canopy over 37,500 sq. ft.
Combination Tier 5	\$56,000+\$860 per 500 sq. ft. of cultivation canopy over 65,000 sq. ft.

AU Cultivator (AU Conditional Cultivators only)	
25,000 sq. ft. Mixed Light with max. 20 lights - \$19,000	

AU Cooperative or Collective License: Outdoor	
Outdoor Tier 1	\$15,000+\$0.25 per sq. ft. of cultivation canopy up to 25,000 sq. ft.
Outdoor Tier 2	\$20,000+\$0.25 per sq. ft. of cultivation canopy over 25,000 and less than 50,000 sq. ft.

Outdoor Tier 3	\$25,000+\$0.25 per sq. ft. of cultivation canopy over 50,000 sq. ft. and less than 100,000 sq. ft.
Outdoor Tier 4	\$30,000+\$0.25 per sq. ft. of cultivation canopy greater than 100,000 sq. ft.

AU Cooperative or Collective License: Mixed Light	
Mixed Light Tier 1	\$20,000+\$0.25 per sq. ft. of cultivation canopy up to 25,000 sq. ft.
Mixed Light Tier 2	\$25,000+\$0.25 per sq. ft. of cultivation canopy over 25,000 and less than 50,000 sq. ft.
Mixed Light Tier 3	\$30,000+\$0.50 per sq. ft. of cultivation canopy over 50,000 sq. ft. and less than 100,000 sq. ft.
Mixed Light Tier 4	\$35,000+\$0.50 per sq. ft. of cultivation canopy over 100,000 sq. ft.

AU Cooperative or Collective License: Indoor	
Indoor Tier 1	\$30,000+\$0.75 per sq. ft. of cultivation canopy up to 25,000 sq. ft.
Indoor Tier 2	\$35,000+\$0.75 per sq. ft. of cultivation canopy over 25,000 and less than 50,000 sq. ft.
Indoor Tier 3	\$50,000+\$0.75 per sq. ft. of cultivation canopy over 50,000 sq. ft. and less than 100,000 sq. ft.

AU Cooperative or Collective License: Combination	
Combination Tier 1	\$20,000+\$0.25 per sq. ft. of cultivation canopy up to 25,000 sq. ft.
Combination Tier 2	\$25,000+\$0.25 per sq. ft. of cultivation canopy over 25,000 and less than 50,000 sq. ft.
Combination Tier 3	\$30,000+\$0.25 per sq. ft. of cultivation canopy over 50,000 sq. ft. and less than 100,000 sq. ft.
Combination Tier 4	\$35,000+\$0.25 per sq. ft. of cultivation canopy over 100,000 sq. ft.

AU Cooperative or Collective License: Combination	
Combination Tier 1	\$20,000+\$0.25 per sq. ft. of cultivation canopy up to 25,000 sq. ft.
Combination Tier 2	\$25,000+\$0.25 per sq. ft. of cultivation canopy over 25,000 and less than 50,000 sq. ft.
Combination Tier 3	\$30,000+\$0.25 per sq. ft. of cultivation canopy over 50,000 sq. ft. and less than 100,000 sq. ft.

Combination Tier 4	\$35,000+\$0.25 per sq. ft. of cultivation canopy over 100,000 sq. ft.

Extraction, infusing and blending, and packaging, labeling and branding	\$7,000*
Infusing and blending, and packaging, labeling and branding	\$2,000 *
Packaging, labeling and branding, including for the performance of white labeling agreements	\$2,000**

\*\*per processing premises, provided however, for a Tier 1 or Tier 2 Cultivator License, the processor license fee shall be \$500 per premises

<b>AU Distributor License*</b>	\$7,000 per operating premises

<b>AU Retail Dispensary License</b>	\$7,000 per operating premises
<b>Limited Retail Consumption Facility Fee</b>	\$3,000

\*\$3,000 fee is waived if the limited retail consumption facility is within 200 ft. of a public housing facility

Cultivation	Tier 5 AU Cultivator fee, based on canopy type
Processing	AU Processor fee, based on type
Distribution	AU Distributor fee

ROD Licensing Fee	
A ROD shall pay:	
- \$175,000;	
- the Tier 5 AU Cultivator fee, based on canopy type;	
- and a \$20 million special fee, as set forth in Cannabis Law and regulation that is paid over time.

<b>AU Cooperative Distributor Fee</b>	\$3,500 per operating premises
