RESOLUTION TO CONSIDER RENEWAL OF REGISTRATION FOR MEDMEN, INC.

WHEREAS, pursuant to Section 10(1) of the Cannabis Law, the Cannabis Control Board (Board) has the authority to issue any registration, license or permit;

WHEREAS, pursuant to Section 35(4) of the Cannabis Law, a registration issued to a registered organization under Section 35 of the Cannabis Law shall be valid for two years from the date of issue;

WHEREAS, pursuant to Section 35 of the Cannabis Law, an applicant for registration as a registered organization under Section 34 of Article 3 of the Cannabis Law must provide certain information to the Board prior to registration approval;

WHEREAS, pursuant to Section 113.8 of Title 9 of the New York Codes, Rules and Regulations, an entity must submit an application for renewal as a registered organization with the Office of Cannabis Management (Office) for subsequent approval or denial by the Board;

WHEREAS, MedMen, Inc. registered by Article 3 of the Cannabis Law has completed such application for registration renewal to the satisfaction of the Office;

WHEREAS, pursuant to Section 10(1) of the Cannabis Law, the Chairperson of the Board has made a preliminary determination to grant a renewal of registration to MedMen, Inc. which has applied for renewal through the aforementioned application process;

WHEREAS, the members of the Board waive their right pursuant to Section 10(1) of the Cannabis Law to take up to 14 days from the Chairperson’s preliminary determination to object to the Chairperson’s preliminary determination or to request that the matter be brought before the full Board for consideration;

WHEREAS, no member of the Board objects to the Chairperson’s preliminary determination to grant a renewal registration to MedMen, Inc. which has applied for renewal through the aforementioned application process;

WHEREAS, the Board desires to grant a renewal registration to MedMen, Inc. which has received the Chairperson’s aforementioned preliminary determination to grant renewal registrations; now, therefore, be it

RESOLVED, that the Board grants registration renewal to MenMen, Inc. which has received the Chairperson’s aforementioned preliminary determination to grant renewal of a registration.
