A single queue was created providing the Office with the order in which to review Adult-Use applications. The random queuing process was audited by an independent third-party to ensure it was random and unbiased.

IMPORTANT: The queue order **solely** determines the order in which the Office will begin the review of each application. The order does **not** indicate the order in which licenses will be issued. Each application is different, and the length of the review time will vary from application to application. Inclusion on this list is **not** a guarantee of licensure and is **not** an indication of sufficient eligibility for a license. The Office will be reviewing applications on the queue for all aspects of license eligibility including, violations of ownership requirements and participation in illicit market activity during application review.
