## RESOLUTION TO DENY CERTAIN ADULT-USE CANNABIS LICENSES

**WHEREAS**, pursuant to Article 4 and Section 10(1) of the Cannabis Law, the Cannabis Control Board (Board) is given the discretion to deny licenses related to adult-use cannabis;

**WHEREAS**, pursuant to Article 4 of the Cannabis Law, the Board is charged with the responsibility of overseeing activities related to adult-use cannabis;

**WHEREAS**, pursuant to Sections 62, 64, 72 and 85 of the Cannabis Law, the Board is charged with the responsibility of overseeing applications for adult-use cannabis retail dispensary licenses, selection criteria for adult-use cannabis retail dispensary licenses, and ownership and operation of adult-use cannabis retail dispensary licenses;

**WHEREAS**, pursuant to Section 8, the Office of Cannabis Management is charged with the responsibility of exercising the powers and duties provided by the Cannabis Law, including making recommendations to the Board;

**WHEREAS**, on or about August 25, 2022 through September 26, 2022, persons submitted applications with the Office for a conditional adult-use dispensary (CAURD) license;

**WHEREAS**, after having reviewed Cannabis Law and the New York Codes, Rules, and Regulations, laying out the licensure criteria, the Office reviewed the applications to determine whether they satisfy the licensure criteria;

**WHEREAS**, upon such review, the Office determined that the CAURD applications identified on [Attachment A] do not satisfy the licensure criteria for the reasons set forth in the supporting documentation, and has recommended denial of licensure;

**WHEREAS**, the Chairperson of the Board, based on the Office’s recommendation and supporting documentation, has made a preliminary determination to deny conditional adult-use retail dispensary licenses to certain individuals and entities that have applied for a CAURD license;

**WHEREAS**, the members of the Board, waive their right pursuant to Section 10(1) of the Cannabis Law to take up to 14 days from the Chairperson’s preliminary determination to object to the Chairperson’s preliminary determination or to request that the matter be brought before the full Board for consideration;

**WHEREAS**, no member of the Board objects to the Chairperson’s preliminary determination to deny certain

conditional adult-use retail dispensary licenses, and no member of the Board requests that the matter be brought before the full Board for consideration;
