RESOLUTION TO APPROVE CERTAIN REGISTERED ORGANIZATION DISPENSING FACILITY REQUESTS

WHEREAS, pursuant to Section 35(3)(e) of the Cannabis Law, the Cannabis Control Board (Board) may amend a registered organizations registration, in part to allow a registered organization to relocate its dispensaries within the state or to add additional dispensaries as allowed under the Cannabis Law;

WHEREAS, pursuant to Section 35(8) of the Cannabis Law, a registered organization may have four wholly owned medical cannabis dispensaries and once acquired, such registered organization may have an additional four dispensing sites, provided the first two additional dispensing sites are located in underserved or unserved geographic locations;

WHEREAS, pursuant to sections 113.7(h) and 113.11(b) of Title 9, the Board may allow for additional dispensing facilities where the registered organization has met criteria as required in regulation for the approval of additional registered dispensing facilities;

WHEREAS, the Office has reviewed the information submitted by Fiorello Pharmaceuticals, Inc, Curaleaf NY, LLC, and Hudson Health Extracts, LLC and recommends to the Board to approve such additional dispensing facilities to amend the registered organization’s registrations.

WHEREAS, applications for dispensary facilities have been submitted by Fiorello Pharmaceuticals, Inc, Curaleaf NY, LLC, and Hudson Health Extracts, LLC and are pending before the Board; now therefore, be it

RESOLVED, that the Board approves by majority vote and through the adoption of this resolution, the dispensary facility requests as set forth in Attachment A, B C and D.
