## RESOLUTION TO APPROVE CERTAIN REGISTERED ORGANIZATION APPLICATIONS FOR REGISTRATION

**WHEREAS**, pursuant to Section 10(1) of the Cannabis Law, the Cannabis Control Board (Board) has the authority to issue any registration, license, or permit; and

**WHEREAS**, pursuant to Section 35(9) of the Cannabis Law, the Board shall register additional registered organizations to provide services to unserved and underserved areas of the state and shall actively promote racial, ethnic, and gender diversity when registering additional registered organizations; and

**WHEREAS**, pursuant to Section 35 of the Cannabis Law, an applicant for registration as a registered organization under Section 34 of Article 3 of the Cannabis Law must provide certain information to the Board prior to registration approval; and

**WHEREAS**, pursuant to Section 113.8 of Title 9 of the New York Codes, Rules and Regulations, an entity must submit an application for registration as a registered organization with the Office of Cannabis Management (Office) for subsequent approval or denial by the Board; and

**WHEREAS**, the Chairperson of the Board has made a preliminary determination to approve such applications for registrations to certain individuals and entities that have applied to become registered organizations that have met the requirements of Part 113 of Title 9 of the New York Codes, Rules and Regulations, as identified in Attachment A hereto; and

**WHEREAS**, the members of the Board waive their right pursuant to Section 10(1) of the Cannabis Law to take up to 14 days from the Chairperson’s preliminary determination to object to the Chairperson’s preliminary determination or to request that the matter be brought before the full Board for consideration; and

**WHEREAS**, no member of the Board objects to the Chairperson’s preliminary determination to approve certain applications for registrations, and no member of the Board requests that the matter be brought before the full Board for consideration; and

**WHEREAS**, the Board desires to approve applications for such registrations as indicated, of every applicant that has received the Chairperson’s aforementioned preliminary determination to approve said applications for such registrations as identified in Attachment A hereto; now, therefore, be it
