## RESOLUTION TO APPROVE CERTAIN CANNABIS LICENSE AND PERMIT AMENDMENT REQUESTS FOR THE PURPOSE OF A CHANGE IN THE LOCATION OR CULTIVATION TIER OF A LICENSEE OR PERMITTEE’S LICENSED PREMISES OR STUDY SITE

**WHEREAS**, pursuant to Section 13(1), Section 67(2), Section 126(1), and Section 129 of the Cannabis Law, upon application by a licensee or permittee, the Cannabis Control Board (Board) may authorize the amendment of a cannabis license or permit, in part to allow such licensee or permittee to relocate its licensed premises, cultivation tier or study site within the state as allowed under the Cannabis Law;

**WHEREAS**, pursuant to Section 120.18(d)(1)(iii), Section 132.9(g)(ii), and 130.7(f) of Title 9 of the New York Codes, Rules and Regulations, the Board may allow for the amendment of a cannabis license or permit for the purpose of a location change of such licensee or permittee’s licensed premises or study site, where the licensee or permittee has submitted an application for such amendment of its cannabis license or permit and has met criteria as required in regulations to change the location of such licensed premises or study site;

**WHEREAS**, the Office of Cannabis Management has reviewed the information which has been submitted by certain cannabis licensees or permittees, for the amendment of such cannabis license or permit for the purpose of a location change of such licensee or permittee’s licensed premises or study site, and recommends to the Board to approve such change of location amendment of certain licenses and permits as set forth in Attachment A;

**WHEREAS**, applications submitted by certain cannabis licensees or permittees requesting a location change as identified in [**Attachment A**], for the amendment of their cannabis license or permit for the purpose of a change of location or cultivation tier/type, of such licensee or permittee’s licensed premises or study site, are pending before the Board; now therefore, be it

**RESOLVED**, that the Board approves by majority vote and through the adoption of this resolution, such change of location or cultivation type amendments of certain licenses and permits as set forth in Attachment A.
